

# I MAKE AMERICA – THE UTILITY EXPO Kubota Sidekick UTV Giveaway

## Official Rules

### NO PURCHASE NECESSARY

1. SPONSOR: Association of Equipment Manufacturers, 6737 W. Washington Street, Suite 2400, Milwaukee, WI 53214 (“AEM”).

2. HOW TO ENTER: An eligible entrant must electronically register and complete at minimum one of three modules offered by signing up for and through the AEM I MAKE AMERICA Campaign during THE UTILITY EXPO, 2025. **THIS IS A SWEEPSTAKES GIVEAWAY (“GIVEAWAY”) AND NOT A LOTTERY. NO PURCHASE NECESSARY TO ENTER OR WIN.**

3. ELIGIBILITY: Anyone who, at the time of entry, is a U.S. citizen or permanent resident and is eighteen years of age or older. Employees of AEM, its promotion and advertising agencies, independent contractors and anyone involved in the development or execution of the giveaway and the immediate families (defined as spouse, parents, siblings, children and their spouses) of such persons and the members of the households of such persons, are ineligible.

4. ENTRY: An entrant accumulates “entries” by completing the offered modules (total of three) in the Interactive Game. Completion of a module earns the entrant one entry. Each module may only be completed once for the purpose of entry for the Grand Prize. The maximum total number of entries that an entrant can accumulate is three. To qualify for the Grand Prize drawing, an entrant must have a minimum of one entry by Midnight EST on October 9, 2025.

5. PRIZE: Prize entries can begin the week of October 6, 2025. The Grand Prize drawing will occur before May 31, 2026. The Grand Prize is listed in Section 6. Delivery of the Grand Prize will occur through a dealership network. All pickup or delivery costs are the sole responsibility of the winner. All entrants agree that AEM is not liable for any loss incurred once the prize has left the dealer’s control. All expenses not specified in these Official Rules, including, without limitation, duties, taxes of any kind whatsoever (including federal and state income taxes on the prize, sales taxes, vehicle registration and document fees, etc.) are the sole responsibility of the winner.

6. PRIZE VALUE: The approximate value of the Grand Prize (a new Kubota Sidekick UTV) is \$14,699.

7. SELECTION OF WINNER: A random drawing for the Grand Prize from among qualified entrants will take place before February 2, 2026. To be declared a winner, AEM (whose decision is final and binding on all aspects of the Giveaway), must first confirm the selected entrant’s eligibility. If a selected entrant is deemed ineligible at the time of the drawing, an

alternate entrant will be selected from among all remaining eligible entrants. Attendance at the drawings is not required to be declared a winner. If a winner cannot be notified within fifteen days after drawing, or in the event of a selected entrant's non-compliance with any of the requirements of these Official Rules, the prize will be forfeited. A winner is free to decline a prize and AEM may select an alternate winner under these circumstances, at AEM's option.

8. **ODDS OF WINNING:** Odds of winning the Grand Prize are dependent upon the number of qualified entrants (see Section 4).

9. **REQUIREMENTS OF WINNER:** The winner must strictly comply with these Official Rules and the failure to do so may, at AEM's option, result in prize forfeiture. The winner will be required to sign (i) an affidavit confirming eligibility and compliance with these Official Rules; (ii) a Publicity Release Form, granting AEM permission to use, without additional compensation, winner's name, city and state address, photograph, likeness, voice, and/or company information for purposes of advertising, promotion and publicity in any and all media (including the internet); and (iii) a Liability Release Form releasing AEM, those involved in the Giveaway's development or execution and other persons from any and all liability arising from this Giveaway and/or the receipt, use or misuse of the prize, including, without limitation, liability for death, personal injury, damage or loss of any kind. The winner shall also be required to provide AEM with all necessary information to report the prize award to the taxing authorities,
